The undersigned Private Contractor(s) hereby enter into a private contract with the Elko County School District (“District”) for the transportation of pupils of the District on the following terms and conditions:

2. The Pupil(s) are the children or wards of the undersigned Private Contractor(s). Private Contractor(s) are not contracted to transport pupils who are not their children or wards.

3. The rate of compensation will be \$_____per day.

4. Only the following members of the immediate family of the Pupil(s) who possess a Nevada Driver’s License in good standing may transport the Pupil(s) under this Contract.

5. This Contract will be in effect during all periods when school is in session for the 2016-17, school year only.

6. The Principal or the appropriate teacher of the school s attended by the Pupil s must, at the end of each school period, certify to the District Clerk the days of attendance of the Pupil(s). Upon receipt of the attendance report(s), the District will issue and deliver to the undersigned Private Contractor(s) a District warrant for the compensation due under this Contract for that period.

7. This Contract will terminate on the occurrence of the earlier of the following events: (A) receipt by either party of written notice of cancellation by the other party for any reason: (B) when the Pupil(s) stops attending the school: or (C) when the school year concludes.

8. The Private Contractor(s) will at all times use extraordinary efforts to insure that the Pupil(s) are transported safely by themselves and all other drivers authorized by this Contract.
9. The Private Contractor(s) and all drivers authorized by this Contract are solely and strictly independent contractors and not employees of the District.
10. The Private Contractor(s) hereby certify that insurance coverage is carried to the limits required by the State of Nevada. The Private Contractor(s) also agree to provide a photocopy of the proof of insurance card issued to them by their insurance company to the District along with this signed contract.
